#### **BOAT DOCK FEES**

## **WILDLIFE AREA RESTRICTIONS**

After much discussion the Board decided that gas powered, motorized vehicles (motorcycles, dirtbikes) will be prohibited on all HOA property. This includes the driving of dirt bikes, motorcycles, cars or trucks on the drainage field and the wildlife area. Those vehicles going to the burnpile, swimming pool, boat storage area, or dumpsters are excluded. Likewise, no motorized vehicles of any type are permitted on the private property of the walking trails.
